

CITY COUNCIL PROCEEDINGS

A regular meeting of the Beach City Council was called to order by Mayor Jeanne Larson on September 7, 2021 at 7:00 p.m. Present when the meeting was called to order was City Council Nick Hegel, Tim Marman, Lynn Swanson-Puckett, Sarah Ross, Bev Wolff, Andy Zachmann, PWS Randy Dietz, City Auditor Kimberly Gaugler, Engineer Jasper Klein, guests Linda Bacon, Jesse Hutchinson, Kaylee Hutchinson, Perry & Nancy Stockwell and Gloria Stockwell.

The Pledge of Allegiance was recited.

Roll call was taken. All members were present.

Public Participation

Representatives of the Beach High School and JR High Book Clubs presented the idea of establishing Little Free Libraries at select locations around the city. The Book Clubs would pay for, care for and stock the Little Free Libraries. The Beach High School Shop Class would build the Little Free Libraries. There would be no cost to the City. Marman moved to support the Little Free Library project, second by Wolff. Motion carried unanimously. Marman clarified that permission will need to be obtained from each property owner of wherever the Little Free Libraries are going to be located.

Minutes

Minutes of the meetings on August 16th and August 20th were presented. Hegel moved to approve the minutes, second by Ross. Motion carried unanimously.

Vouchers

Vouchers were reviewed for payment. Marman moved to withhold payment on portions of the bills submitted by Novotny Construction and Polar Excavating relating to curb and gutter repairs at 645 1st Avenue SW. Public Works Report

PWS Dietz reviewed his written report. Marman moved to approve shipping a load of tires from the landfill, second by Swanson. Motion carried unanimously. Marman recommended Dietz be looking for a newer pickup to be used for cardboard collection.

Auditor Report

Gaugler reviewed her written report. Zachmann moved to close the checking account for the 2021 Street & Utility Improvement Project after final payment has been made and transfer any balance into the regular checking account, second by Wolff. Motion carried unanimously. Swanson-Puckett moved to approve submitting a grant application to T-Mobile for improvements to Gazebo Park, second by Ross. Motion carried unanimously.

Engineer Report

Engineer Klein reviewed his written report. **2021 6th Street Watermain Improvements Project** – A substantial completion walkthrough was completed. A few punch list items remain. Marman moved to approve the Certificate of Substantial Completion, second by Ross. Motion carried unanimously. Contractor’s Application for Payment #5 in the amount of \$106,898.74 was reviewed. Marman moved to amend the City Sales Tax Infrastructure Budget from \$80,000.00 to \$125,000.00 to cover increased expenses due to additional work in the project, second by Ross. Motion carried unanimously. Marman moved to approve Contractor’s Application for Payment #5 in the amount of \$106,898.74, second by Zachmann. Motion carried unanimously. **2021 Street and Utility Improvement Project** - Project closeout is completed and assessment process is ongoing. **2022 NDDOT TAP Multi-Use Trail Project** - The City was previously awarded \$200,000 to proceed with the final phase of multiuse trail project. Klein contacted NDDOT who is willing to extend the bid date to October 2022 with construction in 2023 to allow additional time for the City to secure their share of funding. Marman moved to approve extending the bid date for this project to October 2022, second by Wolff. Motion carried unanimously.

New Business

An Application for Blighted Residential Building Demolition Program at 187 3rd Avenue SW was reviewed. Zachmann moved to approve the application, second by Wolff. Motion carried unanimously.

No other business was brought forward. Zachmann moved to adjourn, second by Hegel. Meeting adjourned at 8:30 p.m.
